## SUMMIT Dissemination Conference - results

The European Council. Spreading knowledge and fostering research on a key institution

### Dissemination Conference 16-17 January 2017

While snowflakes covered roofs and gardens of the historical buildings at Grunewald, leading experts on teaching and re-researching the European Council gathered at the SUMMIT dissemination conference at the "Europäische Akademie Berlin" (EAB). After the hosts Eckart Stratenschulte (EAB) and Wolfgang Wessels (CETEUS, University of Cologne) had welcomed the participants, discussions evolved quickly on how the European Council can contribute to solving the manifold crises of the EU, and on how knowledge of these processes can be made more accessible to the public.

### The European Council: An Anchor in Stormy Times?

In his keynote speech, Jim Cloos, Deputy Director-General for General and Institutional Policy at the General Secretariat of the Council of the EU, began his remarks by stressing that the EU faces troubled times since 2008 – especially nowadays in light of Brexit, the increasing distinction between the so-called "ordinary people" and the "elites" and potential changes in transatlantic relations. According to Cloos, the EU needs to respond to the current uncertainty and defend the EU as what it is, namely a Union of states and peoples and a system of checks and balances. He explained why the European Council has always been an anchor in troubled times by referring to its (1) foundation, (2) functioning and (3) role.

## Teaching the European Council: Approaches and tools

In the second session the panelists Miriam Vogel (Bundeszentrale für politische Bildung), Susana Muñoz (University of Luxembourg), Marieke Eckhardt (University of Cologne), Jürgen Mittag (German Sport University Cologne) and Lenka Curillova (Comenius University, Bratislava) presented their expertise in teaching the European Council. With Hartmut Marhold (Centre International de formation européenne) as chair and Wulf Reiners (Turkish-German University) as discussant, also the suitability of the different tools for different target groups as well as the importance of addressing different senses in teaching were discussed.

## A practitioners' perspective: The role of the European Council for national decision-makers

In session three, Thomas Westphal (Head of Department for European Affairs/Federal Ministry of Finance), Yvonne Nasshoven (Advisor at Office of the Ministers' of State /Federal Foreign Office) and Klemens H. Fischer (Minister plenipotentiary and Head of Department/Permanent Representation of Austria to the European Union, University of Cologne) gave insights into the importance and role of the European Council for national ministries – inter alia regarding the financial crisis. They emphasized the Lisbon treaty as a caesura conveying significantly more power from the capitals to the European Council. The session was chaired by Funda Tekin (CETEUS/University of Cologne, Centre international de formation européenne) and commented by Emmanuel Murlon-Druol (University of Glasgow).

## The European Council: Centre of the institutional architecture?

In session five Christophe Hillion (Universities of Leiden, Gothenburg and Oslo), David Schäfer (London School of Economics) and Sergio Fabbrini (LUISS, Rome) examined the European Council's role in the EU's institutional architecture. A legal analysis was given by Christophe Hillion and followed by a contribution of David Schäfer on venue shopping between the European Council and the Council. Sergio Fabbrini took on a critical position regarding the European Council's high degree of intergovernmental influence. The session was complemented by Sebastiaan Princen (Utrecht University) as commentator and Christine Neuhold (Maastricht University) as chair.
